

## SIFC Sponsorship

Sponsor will donate a monetary or an in-kind donation to the Club. In return the Club will offer service(s) as specified in the Sponsorship agreement (See *Sponsorship Brochure 2013-14.PDF* attached.) Most of the donations will earn the Sponsor ad space, a service and/or highlighted mentions in various club related media.

Any member that brings a sponsor to SIFC will receive up to 20% to be applied to fees, as a finder's fee. Any vendor, landlord or current sponsor that brings a Sponsor to SIFC will receive 20% of the donated funds. A check will be mailed within 60 days of deposit. All donations made to the Club have to come to the Club in form of a Check made out to Sporting Indiana FC or via Credit Card through the Club. All cash donations must come in the form of a Money Order made to Sporting Indiana FC. All Sponsors will receive the proper tax form.

If donations made to the Club are category specific, it will be specified in the agreement. Donations made to the Club can not be used or associated with a third party activity such as other sponsors enhancements, venue enhancements, Showcase needs or non-Club pay. All funds will be used specifically for club expenses and scholarships.

SIFC Sponsorship Levels are as follows: Club Title Sponsor, Champion Sponsor, Premier Sponsor, Select Sponsor as well as scholarship sponsors called Friends of Sporting Indiana & Gryphon Scholarship (See *Sponsorship Brochure 2013-14.PDF* attached.)

## The High School Showcase Sponsorship

Donations made specifically for The High School Showcase will not be a Club Sponsor. The High School Showcase is a separate entity managed by the Club. If the Sponsor(s) wants to donate to the Showcase and the Club, it will be specified in the agreement.

If donations made to the Showcase are category specific, it will be specified in the agreement. Donations made to the Showcase can not be used or associated with a third party activity such as other sponsors enhancements, venue enhancements, Club needs, scholarships or non-Showcase pay. All funds will be used specifically for Showcase expenses.

Any member that brings a sponsor to The Showcase will receive up to 10% to be applied to fees, as a finder's fee. Any vendor, landlord or current sponsor that brings a Sponsor to The Showcase will receive 10% of the donated funds. A check will be mailed within 60 days of deposit. All donations made to the Showcase have to come to the Club in form of a Check made out to Sporting Indiana FC or via Credit Card through the Club. All cash donations must come in the form of a Money Order made to Sporting Indiana FC. All Sponsors will receive the proper tax form.

## Club Scholarship Fund

SIFC developed the Gryphon Scholarship Program to ensure that all children who want to play the game of soccer can play soccer. Contributions to this program will only be used for scholarships as approved by SIFC. If donations made to the Club are Scholarship specific, it will be specified in the agreement. Donations made to the Club that are scholarship specific, can not be used or associated with a third party activity such as other sponsors enhancements, venue enhancements, Showcase needs or non-Club transactions. All funds will be used specifically for scholarships.

## Friends of Sporting Indiana FC

Friends of Sporting Indiana FC can make contributions to the club in any dollar amount. Contributions are applied to scholarships, programs and/or activities that benefit specific members of the club. Friends are recognized on the Sponsor page of SIFC's website or can remain anonymous.

If donations made to the Club are Scholarship specific, it will be specified in the agreement. Donations made to the Club that are scholarship specific, can not be used or associated with a third party activity such as other sponsors enhancements, venue enhancements, Showcase needs or non-Club transactions. All funds will be used specifically for scholarships.
